Biomass UK No.2 Ltd. Incinerator, Barry Dock

We are concerned you call this "*Barry Energy Production Facility*" rather than "a waste installation generating energy", so may not treat it with due seriousness.

We hear you apologised that your officers "*did not inform local political leaders as planned and local residents were not specifically notified*" over the licensing consultation. Much of Barry can be impacted from the incinerator plume, yet you have taken no steps to notify people, not even the businesses next to the incinerator.

Some nearby streets have been notified of the meeting organised by Jane Hutt AM, but nothing from the NRW.

You have offered to supply the application documents on a CD, some 36 plans and technical documents. Please supply the non-technical summary that's needed to make consultation real.

There are maps showing the pollution plume would spread far over Barry – one plume mainly over the Waterfront's new housing, another over the Buttrills hill. Can we trust these predictions when they depend on winds measured at Rhose airport, not the very different wind pattern in Barry ? They show levels of NO2, but not more dangerous nano-particles.

The dust and pollution from the site would affect the nearby residential area, while the noise is likely to be disturbing night-time. The stocks of combustible waste wood-chips contain paint and significant amounts of plastic. Fires from wood-chip stores have burned for days on Newport Docks and at Coity/Bridgend, emitting nauseous fumes.. Are you requiring the company to demonstrate that accidental wood-chip fires cannot happen here?

We ask you for full information, including a public exhibition with public question-and-answer session on how you would propose to license this polluting, bad-neighbour operation. We are happy for the DIAG group (Docks Incinerator Action Group) to liaise with you over suitable arrangements.

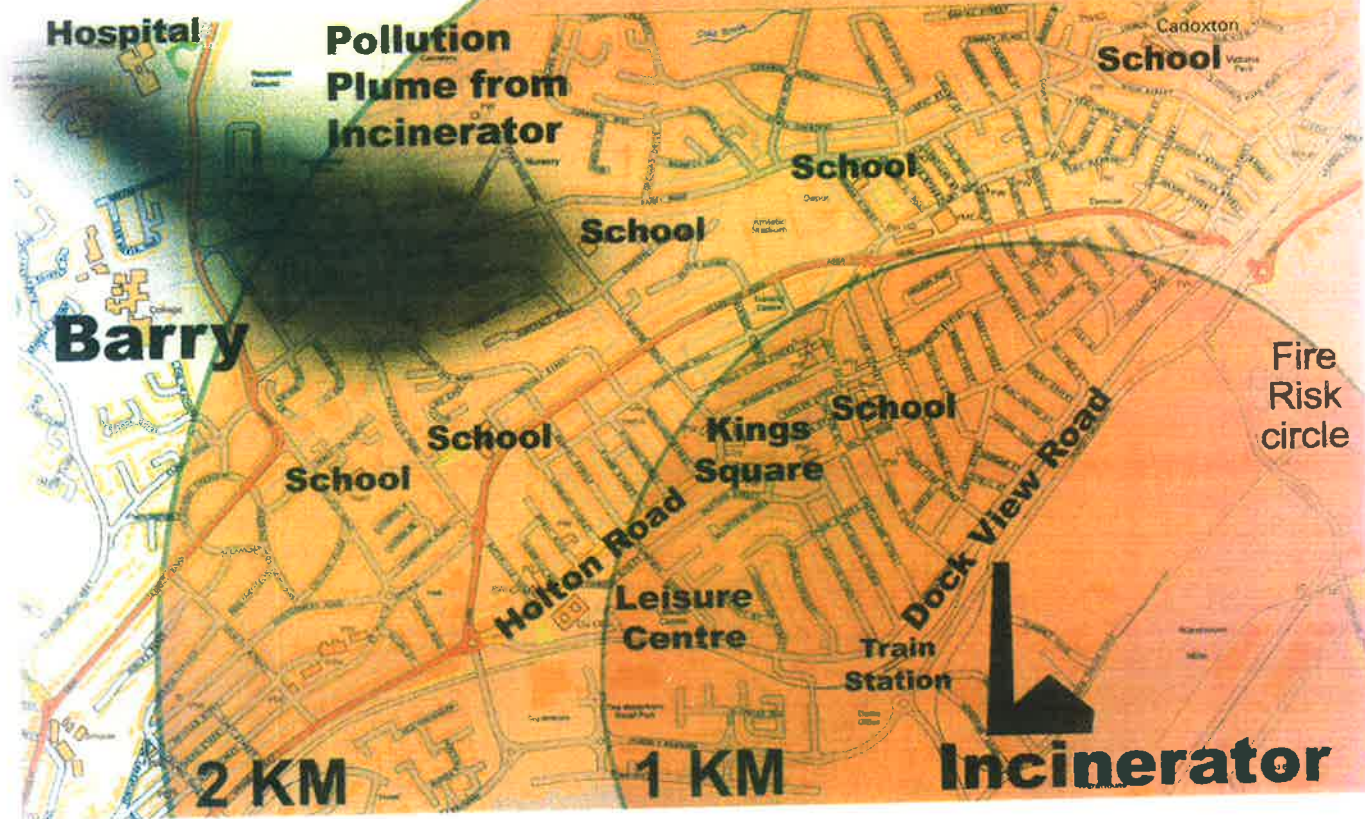

I am concerned at this major industrial plant so close to the town and calling it "Barry Energy Production Facility" rather than a "waste installation generating energy". Much of Barry can be impacted from the incinerator plume, yet you have taken no steps to notify people, not even the businesses next to the incinerator.

To match your promise of real consultation, you need to supply copies of the 36 plans and technical documents in local Council offices and library. The documents show pollution maps over the Waterfront and other housing on Barry's hills. Dust and pollution from the site would also affect the nearby residential area, while the noise is likely to be disturbing night-time.

The stocks of combustible waste wood-chips contain paint and significant amounts of plastics. Fires from wood-chip stores have burned for days on Newport Docks and at Coity/Bridgend, emitting nauseous fumes. Please supply full information, not just the company's biased documents. Let's have an exhibition with public question-and-answer session, where you can listen to the public
