G1 –Monitoring of emissions and environment – Biofilter

Thank you for submitting your report on the bio filter (reference FCCE16D_02_final) as per condition Table S3.1 of your permit. Your report highlights that the geometric mean odour concentration of the air emitted from the biofilter was 1540 OUe/m3. This equates to a 81% removal efficiency.

The air flow data for Table 1 of the report seems to be inconsistent. The combined inlet air stream seemed to be significantly lower than the combined outlet airstream (2.5 times less). The report mentions that measurements might be an indication of a leak. In comparison, in the 16th January 2017 MBT biofilter odour report, the difference between the combined air stream and combined outlet stream was significantly less during this monitoring period.

Action 1: Please confirm if an investigation has been undertaken to ascertain if there is a leak? And what did this conclude?

Action 2 The report also mentions that flow measurement locations were non-compliant with the requirements of ISO 10780. Please could you clarify what the non-compliances are? And how much would this effect the uncertainty measurements. Please respond by 4th March 2019

We advise that the site continue to monitor the bio filter performance closely and ensure that the Odour Management plan is followed. You have confirmed that that the site have the replacement of the bio filter media scheduled in for 2019
