### Introductory note

**This introductory note does not form a part of the notice.**

The following notice gives notice of the variation and consolidation of an environmental permit.

This permit variation will allow Newport County Council to increase the total annual tonnage accepted on site from 103,500 tpa to 171,750 tpa and for the on-site asbestos cell to accept additional waste code 17 05 03\* (soils and stones containing hazardous substances). The total tonnage of waste that the site will receive over its lifetime remains unchanged.
