4. Details of our assessment

NRW carried out an unannounced OOH site inspection at Hanson cement on the evening of the 27th November 2021. We met with the shift manager who advised that due to Storm Arwen they had had quite a bit of damage caused to the flashing on main slope of the clinker storage dome which had been identified during his site walk and the decision had been made to stop Kiln 4 as some dust was identified as escaping from this damaged area.

The shift manager explained he was due to carry out a handover with the incoming shift manager and conversations had been had with regards sending a Schedule 5 notification to NRW for this stop and this was in the process of been completed. A Schedule 5 notification was provided via email to NRW whilst we were on site.

We walked down to the clinker store building to check the damage and there were several corrugated panels on the roof which were loose and visibly flapping around in the wind. There was no obvious signs of dust emissions at that time, however the kiln was not operational at this time.

We also checked the crane store where we had noticed dust emissions on our previous inspection (25/11) but again as the kiln was not operational there was no dust emissions evident at this location.

The 3 doors on the side of the crane store were still ajar as noticed on our inspection on the 25/11 - the shift manager explained that the doors needed to be opened to be able to push the material back within the building and that due to the high winds and bad weather as a result of Storm Arwen they had not had a suitable window of time to carry out this work so far. There did not appear to be any visible dust emissions from these doors at the time of our inspection.

As the kiln was not operational during our inspection, following the above checks we left site.
