4. Details of our assessment

Solutia UK Ltd notified NRW using a Part A Notification on 30th June 2021 of a small leak of formalin during a routine off loading operation. This was contained at the time.

A Part B Notification was provided to NRW on 3rd December 2021. This detailed that an

estimated 6kg of formalin had been released due to a seal leak on an offloading pump. This had all been contained and no liquid had entered the drainage system. The subsequent investigation had determined that the pump seal had failed as a result of cumulative periods of dry running.

To prevent a similar repeat occurrence a number of actions had been instigated, these were;

- change tanker off loading procedure
- retrain all tanker operators

Both these actions had been completed.

In addition the installation of dry run protection is under consideration.

In view of the small quantity of formalin released, the additional protective measures that have been implemented, prompt notification of NRW, and the absence of any identified environmental contamination, no permit non-compliances have been recorded.
