4. Details of our assessment

Correspondence received from Gwynedd Council on the 16th December 2021 indicated that the WAMITAB certificate for David Evans expired in November 2021. As a consequence, the site is currently not covered by a technically competent manager with the correct WAMITAB qualification to manage closed landfill sites.

It is understood by Natural Resources Wales that David Evans is due to undergo his continued competency in January 2022.

A **category 4 breach** has been applied against permit condition **1.1.1b “The operator shall manage and operate the activities using sufficient competent persons and resources”**.

Action: Ensure that the site has a sufficiently qualified Technically Competent Manager in position by the 28th February 2022.
