4. Details of our assessment

NRW received a request on 14th December 2021 from SIMEC Uskmouth Power Ltd to extend the period that had been previously granted under CAR 0035859 for the non-provision of soil and groundwater periodic monitoring data.

The request is justified on the basis that the installation remains non-operational and this is unlikely to change during 2022, also, since the previous round of monitoring there had

been no recorded incidents with potential to cause soil or groundwater contamination.

NRW agree to the request and on this basis the due date for the next soil and groundwater periodic monitoring data required under Permit Condition 3.1.5 is extended until 31st July 2023.
