Celsa Manufacturing UK Ltd. reported in their W1 February 2018 monthly report that the limit value for Suspended Solids had been exceeded. A Schedule 1 Notification was provided on 20th April 2018.

The W1 Suspended Solids limit value is 80 mg/l, the reported value for February 2018 was 81 mg/l. An investigation was carried out and no specific reasons for the exceedance were determined. However, there are plans to install a sampling pump with an immersed suction pipe. Presumably to obtain a more representative sample.

In view that the exceedance of the permit limit value was minimal and within the normal uncertainty allowance, on this instance a non-compliance has not been recorded.

However, Celsa should take all reasonable measures to ensure further exceedances of the limit value are avoided.
