I approached Dowlais from the A4060, connecting the A470 and A465 Heads of the Valleys, before reaching the smaller roundabout at the top of A4060, with both my front windows open, I noticed a very strong gassy smell.

Once I approached the small roundabout the smell was no longer present. I then entered Dowlais, still with my windows open, via the High Street and took the first left into Blaendowlais. The immediate left of this street there is a large car park area, driving around this I could smell gas and rotting odour. I then drove along Blaendowlais and the odour was still very much present.

On leaving the area, I drove to the football car park and then Azalea Park the odour at these points were not as strong as Blaendowlais, but still present. I drove into the estate to Calluna Close and the odour was very strong again. Whilst driving back to Blaendowlais, I noticed that the odour wasn't as strong as earlier.

Based on the above findings a Permit non-compliance will be issued on this occasion for landfill odours detected in the community.
