Routine site inspection with Simon Milford – Site Manager

- Landfill was closed on the 10th January due to adverse weather conditions – high winds.
- Reviewed recent odour complaint from High Street, Biffa investigations within 30mins of complaint did not identify any odour in the community, wind was also in opposite direction.
- NRW request copies of the final report of the concrete trail. Please note we will require two copies and Biffa will need to make representations if they require certain sections of this report to be confidential,
- Biffa's routine FID surveys have not identified any significant odours from site. Surveys are undertaken on a daily basis in the morning.
- Due to adverse weather conditions and heavy rainfall (53mm on the 14th January 2015) Biffa have delayed the installation of 4000m² of temporary capping. This engineering works will recommence during more favourable weather conditions
