- Discussed previous site inspection where it was noticeable amount of mud and debris on the highway. Biffa must ensure that staff on site are continually reviewing site amenity around the site. Mud and debris on the highway must be monitored continually and actioned accordingly.
- Asbestos cell engineering starts on the 5th January 2015 and once constructed a CQA plan will be submitted to NRW for approval.
- Routine site inspection identified that Clinical Waste landfill procedures was not being followed. NRW have issued a Permit breach on this occasion for the procedure not being followed.
- Litter on fences (East) of site needs collecting.
