Odour Complaint Investigations 2nd February 2015

18:20 NRW Received notification of an odour complaint in the Pontlloftyn area from the landfill site.

18:45 At Pontlloftyn at top of Reform Street no landfill odour detected. . NRW met with complainant who confirmed odour was detected whilst driving past the site earlier but can sometimes be detected in community.

18:47 Top of Reform Street - Slight landfill odour detected.

18:45 Top of Fochriw Road approaching landfill entrance on left, moderate landfill odour detected.

Wind direction confirmed as approximately West North West (WNW)

Routine Site Inspection 3rd February 2015 with Simon Milford - Site Manager (09:15 - 11:30)

- Discussed last night's odour complaint and we drove into the Pontlloftyn community with SM and Biffa Gas Management Team - No landfill odour could be detected at this time.

- Drove around perimeter of landfill site and a moderate landfill odour was detected and confirmed by Biffa who were going to conduct an investigation that day to determine source.

Summary

NRW will not be issuing a non-compliance of your Environmental Permit on this occasion as we welcome the action plan you are putting in place referenced in your letter dated 30th January 2015. Our decision is based on you getting these procedures implemented this week. However, any further odours detected outside your installation boundary which are substantiated by NRW may result in a Non-compliance of your Environmental Permit.
