4. Details of our assessment

Emissions breaches

Dwr Cymru Welsh Water (DCWW) composite samples are taken from the composite sampler for charging purposes.

Samples taken from the composite sampler at Kepak exceeded the permitted values for suspended solids on the 22nd January 2021 and 22nd September 2021.

These are 2 category 3 non-compliances which could have a minor environmental effect.

The emissions breaches are outlined below. Each table details a category 3 non-compliance based on the emission date.

What are suspended scores?

In line with our guidance, we may suspend scores for up to six months to allow time for remedial action to be taken. Suspended scores will be re-instated if the action is not completed.
