NRW received Work Instruction 33-W006 v2 "AI in line monitor ELV exceedance redirecting the flow" on 21<sup>st</sup> December 2021. The work instruction details the steps to be taken when a non-compliant discharge is detected and describes the process that prevents it from being discharged to sewer.

Work Instruction 33-W006 v2 is accepted. Action 2 is therefore complete and can be closed.
