- Discussed Fire Prevention / safety Plan - NRW require a draft plan to be submitted by 2nd December 2016. - ACTION BIFFA.
- Discussed the manhole infrastructure problem by the Dowlais Rugby pitch and Biffa confirmed that they have now been in contact with Welsh Water and the issue will be rectified with the next two weeks. Further updates to follow - ACTION BIFFA
- The site has installed an extra 3000m2 of extra temporary capping and installed an extra 15 gas extraction pinn wells.
- Community odour monitoring and FID surveys will now be undertaken every day (Mon - Fri). These surveys will be logged and available for inspection by NRW.
- No odours detected at time of inspection
- Wheel wash and dust suppression was operational.
- Bird control active at time of inspection.
