Routine Site Inspection with Simon Milford - Site Manager

- Discussed recent concerns raised at last site inspection regarding landfill gas management - NRW to organise site meeting - ACTION NRW (tbc)

- During site inspection it was noticeable the working area was larger than normal. It was agreed to increase temporary capping in that area. Biffa however did confirm that this area is being prepared for the soil treatment and composting facility.

- No landfill odour detected at time of inspection.

- There was some litter on Fochriw Road that needs collection.

- Bird management operational

- Works being undertaken on GW13 due to faulty groundwater pump - Low flows in this area due to dewatering by adjacent mine. However, this well needs review as this situation may change.

- Fire Risk Assessment still outstanding - Guidance given to site operator

- It was noticed that there were lorries at the weighbridge containing fines that had a significant odour. It was decided to landfill this material but undertake a LOI test and analysis - ACTION BIFFA - Follow up during next inspection
