Routine site inspection with Simon Milford – Site Manager

- No landfill odour detected at time of inspection.
- On site noticed so leachate collecting at the low point close to the working area. Biffa confirmed they are aware of this situation and are in the process of pumping this leachate to the treatment plant.
- Landfill gas / infrastructure – The site has installed an extra 20 gas extraction pinn wells and 11,00m2 of temporary HDPE capping.
- Some mud and debris noticed on the highway towards Dowlais on Fochriw Road. Biffa confirmed on the 5th August 2017 that a road sweeper had been to site and this has now been resolved.
- Bird Control operational
- Wheel wash operational
- Although not discussed at time of inspection NRW are also requesting an update on the Fire Prevention and Mitigation Plan - ACTION BIFFA
