The main purpose of this visit was to discuss the recent changes to the gas management systems and to review first draft of the Fire Prevention and Mitigation Plan.

Gas Management systems – oxygen ~ <1%, Ch4 ~ 50%, CO2 ~35%, Suction pressure -122mb, Flow 2400m3/hr. Main focus of discussion with Steve Thayer GTE was on maintaining this balance, ensuring oxygen is less than 5% and closely monitoring for any increases in Carbon Monoxide. There were concerns raised regarding the increasing in H2S and the difficulty in managing this gas.

Fire Prevention and Mitigation Plan (FPMP) – We spent some time reviewing first draft many amendments required and Biffa to action these and provide an updated version ASAP.

FID Surveys / monitoring have not shown any concern all with limit averaging 10ppm

Discussed the need to use anti-static clothing whilst inspecting / visiting the Gas Utilisation Plant (GUP). Biffa to confirm company policy however did confirm that hi visibility trousers must be worn at all time and best practice to be orange.

Bird control operational, dust management operational and no landfill odours discussed at time of inspection
