Routine Site Inspection with Simon Milford - Site Manager.

- Discussed Fire Prevention and Mitigation Plan - Biffa confirmed that a draft plan had been written and will be forwarded to NRW for comment. - ACTION BIFFA

- Bird Control operational at time of inspection

- Wheel wash routine maintenance was being undertaken at time of inspection and a road sweeper was on site as an interim measure during these works.

- No wind blown litter and debris observed during site inspection.

- During site inspection a slight / moderate leachate type odour was detected on the perimeter road in close proximity of the leachate holding tanks. NRW requested further investigation to be undertaken in the area in order to reduce / minimise this odour.

After discussing this with you an FID Survey was requested. However although a report was submitted to NRW the investigation / survey did not take place until 4.5 hours after the inspection. This delay is not acceptable and we would expect any further investigation requests to be undertaken ASAP.

- NRW acknowledge that your consultants Stratus have submitted SNRHW Cell and Separation Bund Phase 5 - NRW will review this report / submission and provide comments to you.
