23<sup>rd</sup> September 2016 (10:00 – 13:00) Routine Site Inspection with Anna Lewis, Kevin Ashcroft, Saul White (Permitting Officers) (NRW) and Matthew xxx (FRS). Simon Milford and Dave Pitt (Biffa)

- Detailed discussion regarding Fire Risk Assessment Plan – discussion focused on previous correspondence regarding fire prevention and monitoring. We are of the opinion that this plan should include what monitoring is undertaken, how often, what is monitored for and why (such as oxygen, methane, CO and temperature for example), what triggers do you use for example 5% oxygen.
- What are the actions undertaken when triggers are being approached or have been reached, who evaluates and checks the monitoring data and how often is this done.
- If a fire is detected on site, what procedures are undertaken, we understand that there is an ICOP however we are of the opinion a more site specific assessment needs to be undertaken reflecting site specific issues such as topography, location and weather.
- On detection of a fire we require detail on firefighting methods (water, soil, nitrogen injection? For example), capabilities of the local FRS and access to water. We also require detail on gas infrastructure, for example do you isolate it or not? Is water the best option?
- The plan must also include a review procedure and root cause analysis. We must be able to demonstrate through reflection and investigation on what caused the fire and what procedures are going to be implemented to prevent a re-occurrence.

General site inspection with no issues identified, wheel wash operational, no odour detected at time of inspection. Sewer (treated effluent line) was being camera surveyed at the time of this inspection.

6<sup>th</sup> October 2016 (09:30 -12:00) Routine Site inspection with Simon Milford

- Discussed recent correspondence with Welsh Water and manhole damage at rugby field – NRW have raised concerns and discussed the issue with Welsh Water directly. Welsh Water have confirmed that further investigations will be undertaken.
- Discussed recent odours in community and other installation that maybe causing the issue.
- Biffa confirmed that an in-depth clean of the highway (Fochriw Road) had been undertaken removed large stones and debris in preparation for the winter.
- NRW reviewed recent FID surveys and odour assessments with no issues identified.
- No issues identified during time of this inspection.
