Thanks for the report. The following are my observations/comments.

- 1] Section 1.5 refers to 3rd lift Phase 4 & Phase 5 (a, b, c & d) 4th lift. App B proforma dark green column B has different lifts. This needs rectifying. It's an understandable error as the numbering is hard to follow.
- 2] As it needs rectifying & reissuing, can we have an electronic copy please. That way we can refer back to the previous ones that I retain.
- 3] That way of referring back to previous report allows me to look at Table 1, p 3. We can therefore see that I1 (Inclinometer 1) has been backfilled around by 1.495m, I2 by 1.62m & I3 by 0.65m. We relate that to Appendix B, Proforma 2 for Inclinometers & there is a difference between the two sets of data. That informs me that the inclinometer is backfilled and not grouted. Ewan Thomas had asked about this detail, but it is not explained. In fairness constructing the inclinometer casing upwards means there is no annulus like a traditional borehole whereby one pulls the casing out while bentoniting the aperture. Here any gap from compacted fill is likely to be placed by fill, I don't perceive it's realistic any other way, though we should have a comment. This leads to point 4.
- 4] Appendix C & displacement. This isn't very well explained. At what level in the inclinometer is the displacement recorded? This reveals a noticeable change and I'm assuming it's on the casing at the top of the berm? There is neither no cross reference to the figures anticipated the SRA review Sept 2014 Rev1. Please can Stratus provide commentary in the revision.
