Further to the extra detail provided by Richard Clarke of Stratus. It confirms that the reports are fine. The last part of the Stratus letter refers to SLR sending in a separate report to answer outstanding issue. I am assuming that is a reference to my wanting commentary of the displacement in relation to that within the SRA. We've still not had that, but with cumulative displacement of 120mm over 5+m we are not overly concerned.

NRW are content for you to progress and we get the discussion and commentary in time, if not for this phase, we will want it on the next.

- Discussed concrete pad for soil treatment - further meetings and discussions to follow especially focusing the stability of the concrete pad infrastructure and impermeable base

- Discussed and Audited recent FID surveys - no issues identified highest reading recorded 11ppm (fresh waste odour)

- Routine inspection on site - no odours detected, discussed phasing plan.

- Bird control operational, Wheel wash operational
