- Discussed Fire Prevention and Mitigation Plan (FPMP) for the site, more amendments to this report is required and another updated version to be submitted to NRW for review and comment. NRW requests an updated report by Friday 10th November 2017.
- Discussed HRA Review that is required next year, Biffa in the process of collating data for this report. Biffa will be updating the the previous HRA by ESI.
- CQA Report for construction change to protection layer on liner – Telecon with Ewan Thomas. Biffa need to demonstrate protection from puncture and how it compares to existed material using a CBR Test. The proposed clay may need to be engineered to a thicker layer to meet current protection standards. Biffa will also need to demonstrate that the first layer of waste against this material will be manged effectively to reduce the risk of liner damage.
- Furthermore, Biffa will need to confirm that gas management and leachate drainage will nit to adversely affected by the changes in this design. NRW require a written report confirming and addressing the above issues / concerns.
- No landfill odours detected at time of inspection.
