Scheduled audit of gas compound 8th Feb 2018.

Summary

1.	Site security	Designated parking and sign-in procedure In operation at Trecatti site offices as well as the gas compound.
2.	Health and safety	Site staff checked correct PPE was worn. Safety induction was carried out at the gas compound. DSEAR markings in place. Trip hazards clearly marked.
3.	Cleanliness	Gas compound exceptionally clean. Waste segregated correctly. Lids in place. No oil stains to ground. However, floor of gas flare stack full of debris and requiring a clean out.
4.	Vermin/pests/birds	No vermin spotted. Flocks of Starlings present, however this was not seen to be a problem as they were not on the tipping face. Site remains open to public complaints at the site of birds over the site and must remain vigilant.
5.	Odour	No odour detected on or off site at the time of the inspection.
6.	Noise	No excess noise present on site.
7.	Gas Compound overview	A comprehensive overview of the site operation was given by site staff. The description followed the gas entering the compound, gas scrubbing techniques, diversion to flare stack, and an overview of the engines present. Currently 4 out of 7 engines were running. The flare stack had not operated for the previous 7 days, and the estimated run time is approximately <1% of the total operating hours which discounts the site needing to carry out extra monitoring according to permit conditions.



Overview of gas compound showing large flare stack on right and a jenbacher landfill gas engine on left.



Incoming gas is logged for quality before being scrubbed. Removal of siloxenes is important to site for performance and longevity of the burners.

The Gas compound was well managed and site specialists were experts in their field. NRW has no issues with the gas compound and will seek to return to site in the 2nd Quarter of the year – Apr/May to carry out an audit on the leachate handling.
