Information was gathered to enable assessment of the incident under CoMAH regulations. The Royal Mint will be informed of the Competent Authority's decision in due course.

This CAR is to confirm Natural Resources Wales verbal agreement that, from 15th May 2015, The Royal Mint may begin cleaning of the area involved in the fire, subject to the condition that tank 4 is removed intact, the contents remain undisturbed and that it is stored somewhere secure, dry and easily accessible to enable a further, more detailed inspection.
