The annual performance reports were received on 28th January 2015. All are satisfactory and accepted. When compared with 2013, production increased by 28% in 2014.

Form Performance 1 for 2014

The total CO_{2e} released in 2014 was 1254.72Kg/tonne circulating coin. This is a reduction of 9.7% compared with 2013.

The total waste produced in 2014 was 0.508tonnes/tonne of circulating coin. This represents a 31.3% reduction compared with 2013.

Form E1 Energy Usage for 2014

Electricity usage was 4.82MWh/tonne of product, a reduction of 17.5% compared with 2013.

Natural gas usage was 0.94MWh/tonne of product. This is a reduction of 18.3% compared with 2013.

Total energy usage of 5.8MWh/tonne of product was 17.1 % less than in 2013.

Form Water Usage 1 for 2014

Mains water use reduced, when compared with 2013, by 24.3% to 4.87m³/tonne of product.

The amount of abstracted water was 6% less than in 2013, despite the projected rise due to problems with the sulphate content of effluent emissions to sewer.

Total water usage decreased to 28.93m³/tonne of product, 9.6% less than in 2013.

Form A1 Emissions to Air, January 2014 to December 2014

These are spot samples and are therefore not truly representative of the site's emissions over the whole year. The values for all determinands are higher than those reported in 2013, but are still well below their respective ELVs and do not give any cause for concern.

The significant reduction in use of resources is most encouraging, particularly the large reductions in waste production and energy usage. There has been a substantial increase in production this year, which may have added some economies of scale to the operation, but Royal Mint should still be congratulated on their more efficient use of resources during 2014.
