4a(i): *Royal Mint (RM) to update Natural Resources Wales (NRW) monthly on progress with the compliance action plan. The first update to be received by NRW by 30th October 2015.*

The first update was received by NRW on 28th October 2015, confirming that the Compliance Action Plan is currently on target.

The report is accepted.

4c(ii): *Investigate feasibility of using one type of valve across the whole RM site. Report results of investigation to NRW by 4th December 2015.*

This report was received on 28th October 2015. It found that replacement of all fittings to a single standard was neither feasible nor desirable. However, as time passes and valves need to be replaced, RM will move towards using a single type of fittings. Any deviation from this will be controlled through Engineering Services.

The report is accepted.

4b: *The schedule and results of the first (pipeline) inspection to be received by NRW by 2nd October 2015.*

The RM have set up a system to inspect the sulphuric acid pipeline to ensure its integrity. The results of two satisfactory inspections have been received by NRW. Since the system appears robust it will only be necessary to submit results to NRW quarterly, while still carrying out monthly inspections. It is hoped that this will enable RM to divert resources onto more pressing areas of this project.
