Form S1, Emissions to Sewer for Q3, July to September 2015, was received on 6th October 2015.

All emissions were less than their respective emission limit values.

Both free cyanide and copper levels have increased compared with the results submitted for Q2 2015, however these results are still low when compared with results submitted to EA/NRW since 2012. It is hoped that the improved controls being introduced in the effluent treatment plant will help to maintain these low emission levels.
