The results show a significant reduction in both free cyanide and copper emissions to sewer. We have been assured that this reduction is not solely due to reduced emissions from CP2 after the recent fire there. It seems as though The Royal Mint's waste stream project is delivering results and all those involved should feel most encouraged. The report is accepted.

All those involved in the waste stream project should be congratulated for these exceptional results which we hope will be continued in the following months. We expect that the Royal Mint will continue this project and consolidate their successes.

Form W1, Emissions to Water, January to June 2015, was received on 1st July 2015.

All the measured parameters are within their respective Emission Limit Values. The report is accepted.
