A damaged skip which was being used to collect filtercake from the filter presses in the effluent treatment plant (ETP) was seen during a site inspection on 12th April 2016. A similar problem had been noted during the waste audit in July 2014 after which procedures were put in place to prevent damaged skips from entering site and being used. The presence of another damaged skip nearly two years later infers that there is a weakness in the control procedures. The Royal Mint (RM) were issued with a Cat 4 non-compliance and asked to put the necessary corrective actions in place by 13th May 2016.

On 11th May 2016 Natural Resources Wales (NRW) received a synopsis of all the corrective actions that had been undertaken and copies of the new and updated procedures. The waste contractor will inspect all skips destined for RM before despatch and record the results on a specially designed form. RM, along with the contractor's haulier, will inspect the skips on arrival and will record the results on the same form. RM will file the completed form in the ETP. Both contractor and RM have documented procedures describing the actions to be taken. RM will train all the ETP operators in this new procedure. NRW will audit this training at some point within the next year.

The procedures are simple and should be effective. NRW accepts the remedial actions that have been put in place and so the actions on CAR|NRW0000168 are closed.
