The report of the results of the October 2015 round of surface water and groundwater monitoring was received on 2nd November 2015.

In this round of monitoring nickel levels increased in BH001, BH10, and BH32. Zinc levels increased by varying amounts in BH001, BH10, BH32 and BH13. Copper levels increased in BH001, BH10, BH32 and BH13. pH values fell in BH001, BH002, BH801, BH10, BH32 and BH13. All were above the lower EQS value of 6.0, except for BH8 (5.6).

Boreholes BH002, BH801, BH8 and BH13 all show reductions in some or all of the metals tested.

It is difficult to comment on the river monitoring results as zinc contamination is evident upstream of The Royal Mint and so increases seen at downstream sites cannot reliably be attributed to this site. However there are elevated levels of copper and nickel downstream of the site.
