Report on Groundwater and Surface Water Sampling in February 2015 and Summary of 2014/15 Monitoring Period

This report was received on 20th March 2015.

Samples were taken from eight boreholes and five river sampling locations and analysed by ESG. The pH was less than in October 2014 in all the boreholes sampled. BH8, BH32 and BH13 all showed a decrease in copper, nickel and zinc concentrations compared with October 2014. The other boreholes, 9, 10, 11, 12 and 901, showed an increase in concentration for at least one metal when the results were compared with those for October 2014. BH 901 had the lowest pH reading and the highest values for cadmium, copper, nickel, zinc and lead. This confirms the comments made previously in CAR KP3135KV/0227322.

Despite all the samples from the river showing a lower pH than in October 2014, all locations also showed reduced metal concentrations. Rainfall in the preceding month was below average for the time of year.

When analysing the historical data from the regular river and borehole monitoring using the Mann-Kendall test, it appears that there is an on-going problem with increasing levels of metal pollution in some areas. This should be investigated and reported, as requested in CAR KP3135KV/0227322, by June 2015.
