The results of the borehole monitoring carried out on behalf of The Royal Mint during 2014 by Celtic, as part of the remediation plan for NP1, were received on 5th January 2015.

The boreholes are on the eastern side of the site and the results include those from river samples taken in various locations upstream and downstream of NP1. This monitoring is not included in the annual SPMP as it relates to a specific area of the site which is undergoing remediation.

In February 2014 there was a significant sulphuric acid leak very close to NP1. Metal concentrations rose significantly and the pH fell significantly, particularly in BHE1 and BHE2, about a month after the leak was detected. There was another peak/trough during April. Neither of these peaks seems to have been detected in the river monitoring samples. Contamination levels now seem to have stabilised, metals being generally lower and the pH higher. There was a peak in metal concentrations at the end of November, but there was no corresponding reduction in pH.

The remediation needs to continue as there are still significant levels of nickel and zinc contamination in some boreholes.
