The report of the results of the June 2015 round of surface water and groundwater monitoring was received on 31st July 2015.

Some boreholes in the north of the site only usually sampled as part of the SPMP monitoring have been added to this four monthly sampling programme.

In this round of monitoring nickel levels increased in BH002, BH801, BH8 and BH13. Zinc levels increased by varying amounts in BH801, BH901, BH8 and BH13. Copper levels increased in BH801, BH9 and BH8. pH values in BH901, BH8 and BH13 were all at or below the lower EQS value of 6.0, however they do show a slight increasing trend.

It is difficult to comment on the river monitoring results as contamination is evident upstream of The Royal Mint and so increases seen at downstream sites cannot be reliably attributed to this site.

The report is accepted.

The actions described in the covering letter from The Royal Mint to Natural Resources Wales are acceptable. We are pleased to see that a contract has been placed to identify culverts that are still in use and to clean them and to seal those that are no longer required.

We confirm that an update in November 2015 on all the proposed work is acceptable.
