During October and November 2015 The Royal Mint undertook a CCTV survey and cleaning programme on the culverted stream which runs under the site and discharges into the Nant Muchudd river.

It was suspected that contaminated sludge in this culvert may have been contributing to the fluctuating heavy metal concentrations seen during the regular river monitoring.

A total of 28 tonnes of solid material was removed from the sections cleaned, with estimated metal contents of 3kg copper, 0.7kg each of zinc and nickel and traces of arsenic, chromium, cadmium and lead. The contaminated material was removed from site as hazardous waste. The culvert was also jetted and the resulting silty water disposed of in an appropriate manner.

Several structural problems were identified during the CCTV survey of the culvert, including holes where ground water infiltration had occurred, poor connections showing voids and circumferential cracking and erosion exposing some steel reinforcement. The outfall was in particularly poor condition.

The Royal Mint are awaiting estimates for the necessary repair work.
