The Site Protection and Monitoring Programme (SPMP), Groundwater Monitoring Round XI, was received on 10th October 2015. It was forwarded to Natural Resources Wales' (NRW) Geoscience department for their specialist opinion. This was received on 12th November 2015.

NRW agree with and support all the recommendations in section 6 of the report. These should be undertaken over the next 12 months and a report on their progress given in the next annual report. We would like to have seen a progress report included with this year's annual report.

There are, however, still some areas of concern.

Concentrations of metals in BH901 are still elevated and the consultant's suggestion concerning further investigation in this area should be taken up as soon as practicable.

Of more immediate concern is the sudden appearance of high levels of chromium (Cr) in boreholes across the site, particularly the eastern side. There are no processes using Cr on this side of the site. Levels of Cr in boreholes sampled in October 2015 as part of the quarterly groundwater and surface water monitoring programme do not confirm the results found in the SPMP monitoring in September 2015. The Royal Mint will continue monitoring as usual and have added hexavalent chromium to the suite of test metals.

We are pleased that the drain identification and cleaning project is having a beneficial effect and that the programme will be continued next year.
