Several of the actions agreed during the meeting on 14th August 2015 between The Royal Mint (RM) and Natural Resources Wales (NRW) to discuss the recent cyanide release and agree the proposed remedial actions were due to be either started by or completed by 1st October 2015.

Agreed actions and timescale

4b). All pipework carrying sulphuric acid to be inspected monthly.

Action: *The schedule and results of the first inspection to be received by NRW by 2nd October 2015.*

A copy of the schedule was received by NRW on 28th September 2015. **This part of action 4b is complete.**

Results of the first inspection were received by NRW on 28th September 2015. There were some parts of the pipeline that were submerged in water. Ducts have been pumped out and the water suitably disposed of. The ducts will be inspected monthly to ensure that they remain clear. These parts of the pipeline will be redesigned and replaced as appropriate. This action, for RM to send results of each monthly inspection to NRW, is on-going. The next report will be due on 6th November 2015. **Action for October 2015 is complete.**

4c). Valves, fixtures and fittings, assembly and use.

Completed Action: Access to valve and fittings restricted.

Action: *Add second photograph to SPL to show the difference between the two nuts. Document to be modified and sent to NRW by 1st September 2015.*

The modified SPL was received by NRW on 27th August 2015. **Action complete.**

Action: *Investigate feasibility of using one type of valve across the whole RM site. Report results of investigation to NRW by 4th December 2015.*

4d). Review use of sulphuric acid in copper plating

Action: *Findings to be received by NRW by 2nd October 2015.*

A trial was run on CP2 to determine whether the use of sulphuric acid in pretreatment could be reduced or eliminated. It concluded that sulphuric acid in the pretreatment stages was essential in producing work of the required quality. Without it the work had to be scrapped. The report was received on 28th September 2015. **Action complete.**

Action, ongoing: *Seek opportunities to reduce or remove sulphuric acid use in all processes across the site.*
