The annual reports for emissions to air, water usage, performance indicators and energy usage for 2016 were received on 26th January 2017.

All the reports are accepted.

Form A1, Emissions to Air, January to December 2016

All the parameters were within their respective emission limit values.

Form WU1, Water Usage 2016

Total mains water usage increased by more than 7% in 2016, but the total volume of abstracted water used fell by more than 20% and overall water used fell by 16%. When production volumes are taken into account mains water usage was almost the same, but abstracted water use was more than 25% less and total water use was more than 20% less than in 2015.

This is a significant reduction in the use of abstracted water and may, in part, be due to a long project to control the amount of sulphate released to sewer. This project is complete and any further benefits should become apparent during 2017.

Form E1, Energy Usage 2016

Energy usage, when adjusted for production volumes, was broadly the same as in 2015.

Form P1, Performance Indicators 2016

Production increased by more than 5% in 2016. The total waste produced per tonne of production fell by more than 6% when compared with 2015. The amount of CO₂ released due to the consumption of electricity and gas was almost 10% less than in 2015.

The reduction in abstracted water consumption and CO₂ released demonstrate The Royal Mint's continuing commitment to efficient raw material use while still being able to increase production volumes. However, total energy consumption has been very similar over the past three years and may benefit from some scrutiny in 2017 to identify any areas where savings could be made.
