Due to some unforeseen problems, The Royal Mint were unable to submit their annual performance reports by the due date of 31st January 2018. However, Natural Resources Wales were informed of the delay and so no further action is necessary.

Form A1, Emissions to Air, was received on 1st February 2018. Forms Performance 1, E1 and Water Usage 1 were received on 21st March 2018.

All the reports are accepted.

Form A1, Emissions to Air, January 2017 to December 2017

None of the parameters exceeded their respective emission limit values.

Form E1, Energy Usage, 2017

Gas and electric use per tonne of product was higher than in 2016. Total energy use per tonne of product was more than 4% higher than in 2016.

Form Water Usage 1, 2017

Use of mains water per tonne of product increased by 18%, whereas the volume of water abstracted fell by 12% compared with 2016. Total water use per tonne of product was 6% less than in 2016.

Form Performance 1, 2017

Production was slightly less than in 2016.

Waste generated per tonne of product was also slightly less than in 2016.

Primary energy use and CO2 generation were 11% and 8% respectively less than in 2016.
