Improvement Conditions

Condition IC4

The Operator shall submit a report in writing to Natural Resources Wales for approval. The report shall define and provide a written justification of the "minimum start up load" and "minimum shut-down load", for each unit within the LCP as required by the Implementing Decision 2012/249/EU in terms of:

i. The output load (i.e. electricity, heat or power generated) (MW); and

ii. This output load as a percentage of the rated thermal output of the combustion plant (%).

And / Or

iii. At least three criteria (operational parameters and / or discrete processes as detailed in the Annex) or equivalent operational parameters that suit the technical characteristics of the plant, which can be met at the end of start-up or start of shut-down as detailed in Article (9) 2012/249/EU.

An email was received on 7th June 2016, which gave details of the proposed changes to the reporting system and specifications of the appropriate MSUL and MSDL criteria. NRW considers that an update should be provided to ensure all the requirements of IC4 have been completed in the period since the first reports were provided.

Condition IC6 (Parts 1 & 2)

The Operator shall submit two reports in writing to Natural Resources Wales for approval. The first report shall provide

proposals for interim reporting of emissions in accordance with IED Chapter III Annex V, Parts 3 and 4 as far as practicable using existing data logging supplemented with manual data processing.

The second report shall provide details of a programme to fully implement IED Chapter III Annex V reporting, reference periods and conditions and start up and shut down criteria by 30 June 2016.

A report for Part 1 was received on 27th January 2016 and Part 2 was received on 31st March 2016. These contained proposals to provide emissions data in a format compliant with the IED requirements.

Part 1 of IC6 is now considered complete.

NRW considers that an updated report for Part 2 should be provided to ensure all the requirements of IC6 have been completed in the period since the first reports were provided. Please also provide evidence to show that 3% oxygen correction is being applied at A2. This should include the calculations and examples of data / screenshots from the reporting system.

Please provide update reports for IC4 and IC6 (Part 2) by **31st March 2017**.

IC5 has already been extended to 30th July 2017 to allow all options to be investigated fully.
