We need more information about your application

Application reference: EPR/JP3632ZH/T003

Applicant: Engie FM Ltd

Facility: Barry Cogeneration Plant, Winbourne Road, Dock 2, Barry, CF63 3DH

Thank you for your application received on 10th October 2016.

I need to ask you for some more information before I can decide whether it is duly made or not. The information required is summarised below:

Application Form D2

1. Section 1(c) the national grid reference provided is incorrect. Please could you provide the correct grid reference?
2. Section 2(b) the ISO 14001 certificate for Engie FM Ltd does not strictly evidence that the installation is being managed in the same way as it was under Cofely Industrial Energy Services. Please could you supply document evidence that the management of the installation under the transferee is substantially the same as under the transferor, as described in paragraph 5 of page 22 of the [Charge Scheme Guidance](#). This will allow us to verify the appropriate fee.
3. Section 4(d)3 requires that a summary of the Environmental Management System be provided. Thank you for providing the ISO 14001 certificate for Engie FM, although please could you describe how this system is applied at the site and whether the transferee's EMS is any different to the transferor's?

Application Form F1

1. Section 1 Table 1 notes the fee as £1,950, which you subsequently paid to Natural Resources Wales. However, NRW's current [Charge Scheme and Guidance](#) explains that there is a fixed charge for this manner of transfer of £1,999. Please see the above point 2 regarding section 2(b) of form D2. If we deem the management to meet the requirements of a standard fee transfer, we would ask that you pay the difference of £49 using the same reference as the previous payment of £1,950 to allow us to track both payments within our accounts.
2. Please could you update the Operator Competence worksheet for the existing Barry

Cogeneration Plant OPRA Spreadsheet so that the OPRA spreadsheet reflects the correct operator post transfer, and forward this document to us?


3. In section 5 you have ticked a box requesting commercial confidentiality. There is no information in the application we would consider warrants commercial confidentiality. Could you confirm if this box was ticked in error?
