An audit of Hazardous Waste/Special Waste Consignment notes was undertaken by Industry Regulation Officer Matthew Kelk and Waste Regulation Officer Paul Challenger on the 6 February 2019.

Consignment Notes were audited for the month of December 2018.

The following information was found to be missing from the consignment notes:-

West Midlands Ambulance Service Trust - missing weights and EWC codes in part E of the consignment notes.

It was accepted that a large number of consignment notes accompanied bulked waste on a single load from the above producer and it would be impossible to produce individual weights associated with each note.

PCS - Weights were missing in part A and Part E of the consignment notes.

Sharp-smart - Information missing from part E of the note.

NHS Scotland - Special Waste Consignment Notes provided, missing information from various part of the notes

It was discussed with Vince Norris that recent meetings had been held with the various parties to ensure that notes were filled in properly. In addition to this toolbox talks has been held internally within Tradebe about the completion of consignment notes.

Paul Russell from Tradebe produced several recent Special Waste consignment notes for medical waste originating from NHS Scotland from the last 2 weeks and it could be seen that the notes were now being filled in correctly. A new weighbridge is being installed on site which in the next 7 weeks which will assist in filling in part E of the consignment notes.

Condition 1.3.1

Without prejudice to the other condition of this Permit, the Operator shall implement and maintain a management system, organisational structure and allocate resources that are sufficient to achieve compliance with the limits and conditions of this Permit.

Condition 2.3.3

All staff shall be fully conversant with those aspects of the Permit conditions which are relevant to their duties and shall be provided with adequate professional technical development and training and written operating instructions to enable them to carry out their duties.

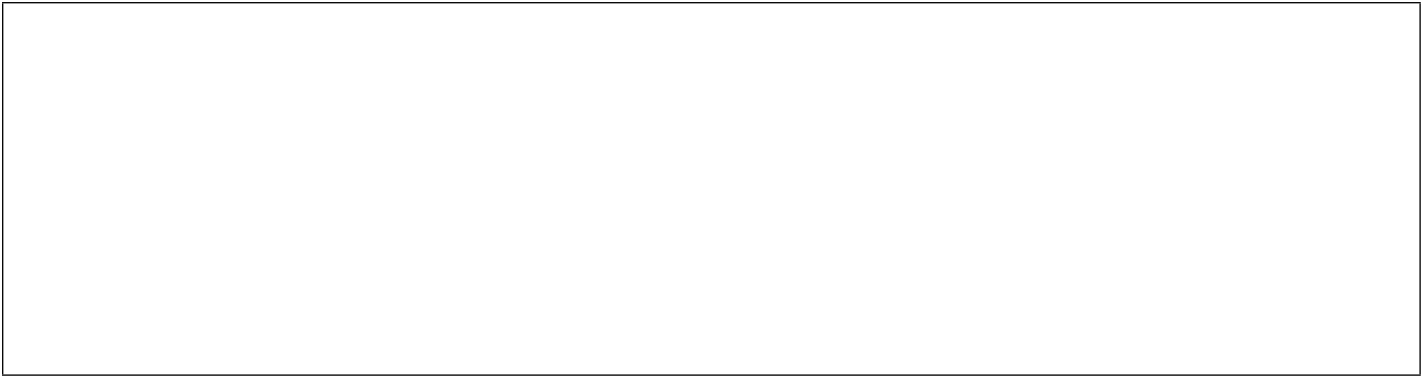
Evidence that EMS procedures and training were not sufficient to ensure that Hazardous Waste/Special Waste consignment notes were properly completed.

Action

Tradebe to review EMS procedure for completion of consignment notes and forward to NRW by 7 March 2019.

Forward logs of training (toolbox talks) to NRW by 7 March 2019.

Breach of condition 1.3.1 and 2.3.3, scored 2 category 4 scores.
