IC10. The Operator shall carry out emissions monitoring for hydrogen chloride and hydrogen fluoride (as F) at air emission points A8/1 and A8/2 when the plant is in full production to measure the emissions to air from the zinc-nickel plating process. Based on the results of the monitoring the Operator shall assess the need for, and develop an on-going monitoring program for the zinc-nickel plating process as necessary. The Operator shall provide a report to Natural Resources Wales (NRW) with proposals for a monitoring program or provide full justification as to why a monitoring program may not be necessary.

This Improvement Condition formed part of the varied permit issued to TRW in 2013. There were difficulties in providing suitable monitoring points and so the agreed completion date was changed.

The emissions monitoring report was received on 22nd October 2015. It showed that emissions of hydrogen chloride and hydrogen fluoride from the new emission points A8/1 and A8/2 from the new zinc-nickel line were well below the emission limit benchmarks given in the sector guidance note for surface treatment. Hydrogen fluoride emissions from both A8/1 and A8/2 were $<0.05\text{mg/m}^3$ (SGN benchmark 2mg/m^3). Hydrogen chloride emissions were 0.77mg/m^3 from A8/1 and 1.22mg/m^3 from A8/2 (SGN benchmark 10mg/m^3).

TRW evaluated the results and sent a report to NRW on 17th November 2015. Since the emissions are less than those given in the sector guidance note, TRW propose conducting air emissions monitoring every three years.

NRW agree with this course of action and will expect to receive the next monitoring report in May 2018, unless informed otherwise by TRW.

Improvement Condition IC 10 is therefore closed.
