TRW had requested a short meeting to discuss proposals for the new anodising plant and the application for a variation to the permit.

Proposals for a new anodising plant

The documentation from the suppliers was considered and discussed. Several observations and suggestions were made for TRW to consider.

Natural Resources Wales (NRW) were invited to attend a meeting in April to consider the proposals in more detail. Representatives from TRW, Germany, the equipment supplier and the chemistry supplier will be present as well as personnel from TRW Pontypool.

TRW will advise NRW of the date nearer the time.

Permit Variation

The anodising plant will be in the same building as the electroplating plants, but in a different area, so will not be able to share any of the existing emission points. The total volume of process tanks in the new anodising plant will be 7.862m³. As there will be a new emission point, A9, TRW will need to apply for a normal variation, rather than the admin variation previously discussed. The cost will be based upon the existing OPRA score and should be about £1500. We recommend that TRW increase the boundary of the permitted area to include the whole site, so that any future changes in the location of equipment will not need a variation to the permit.

It may be useful to gather some emissions data and operational help from the TRW site in Germany.

BAT compliance and other matters were discussed during the pre-app meeting on 10th October 2014.

The application should be submitted as soon as possible so that the permit is in place when commissioning starts on or about 2nd November 2015.
