Forms S1 Emissions to Sewer, WU1 Water Usage 2017, R1 Waste Disposal and Recovery 2017, E1 Energy Usage 2017 and the Fugitive Emissions Review, were received on 31st January 2018.

All the reports are accepted.

Form S1, Emissions to Sewer, 1st July to 31st December 2017

All emissions were within their respective emission limit values.

Production Volumes

Overall there was a 13% reduction in 2017, however there was an increase in zinc-nickel plated parts, with a reduction in zinc plated and anodised parts.

Form WU1, Water Usage 2017

Overall use was 16% less than in 2016 and use per production unit was almost 5% less.

Form R1, Waste Disposal and Recovery 2017

The amount generated was 8% higher than in 2016 and the amount generated per unit of production increased by more than 20%. There was a 6% increase in recycled waste per unit of production, although the overall amount decreased by 11%. The largest increase was in solid hazardous waste where the amount generated per unit of production increased by more than 50%; the increase in liquid hazardous waste was more than 20% per unit of production.

TRW should make waste minimisation a priority in 2018, trying to identify the reasons for the increases in 2017 and then taking appropriate action to reduce waste generation per unit of production. The slight increase in waste recycled is encouraging.

Form E1, Energy Usage 2017

Energy use and CO₂ generation overall were similar to 2016, but there was a 13% increase per unit of production in both.

During 2018 TRW need to focus their efforts on waste minimisation and energy efficiency. The increase in waste generated is significant and should be addressed as a matter of importance.

The slight decrease in water consumption is encouraging.

Reductions in waste generation and increasing energy efficiency would both be economically beneficial to TRW, but may require some initial investment before the benefits are realised.

4.1.4 Fugitive Emissions

Adequate measures are in place to ensure there are no fugitive emissions to land, groundwater and surface water. There were no fugitive emissions in 2017.

Air monitoring conducted on the new emission points from the zinc-nickel process showed that there were no emissions from the process.

Similar tests will be run on the new anodising line when production rises to a suitable level.
