The annual reporting forms for 2015, R1, Waste Disposal and Recovery; WU1, Water Usage and E1 Energy Usage, were received on 4th February 2016. Since the installation of the zinc-nickel plating plant it has not been possible to make a valid comparison of year on year figures, so any comparisons are only made between 2014 and 2015. Production volumes rose by more than 4% overall in 2015, but this was made up from increases in some product lines and decreases in others.

Form S1, Emissions to Sewer, 1st July to 31st December 2015 was received at the same time.

All the reports are accepted.

The review of performance against EMS targets for 2015 was received on 18th February 2016. The report is accepted.

Form S1, Emissions to Sewer, 1st July to 31st December 2015.

The Emission Limit Value (ELV) for zinc was breached on 26th November and TRW were issued with three non-compliances. Corrective actions are proceeding to the agreed schedule.

All the other parameters were less than their respective ELVs.

Form E1, Energy Usage, 2015

Energy usage and CO₂ generation were similar to those in 2014. Production volumes rose in 2015, so energy usage and CO₂ generation per unit of production have fallen by just over 4% and by nearly 5% respectively.

Form R1, Waste Disposal and Recovery, 2015

The amount of waste disposed of fell slightly in 2015 compared with 2014, showing a reduction of 6%.

Form WU1, Water Usage, 2015

Water usage has been increasing since 2013 due to the installation and increased use of the zinc-nickel plating line. Consumption increased by more than 8% in 2015 compared with 2014.

EMS – Review of Performance against Targets for 2015

Almost all of the set targets were met on time or within two months of the target date. It is unfortunate that TRW were not able to arrange ISO 14001 auditor training for some of its employees, (item 30).

The identification of swarf skips (item 70) and spillage training for plant controllers (item 71) are both important targets that should be carried forward into 2016.
