On 14th January 2016 a Schedule 1 notification was discovered in an obsolete Environment Agency email account. It concerned a breach of the emission limit value for zinc emissions to sewer which had occurred on 26th November 2015. TRW were informed of the breach when they received the analysis report from Welsh Water on 14th December 2015. They informed Natural Resources Wales (NRW) via an email sent to an incorrect address.

The ELV for zinc emissions to sewer is 5mg/L, the measured value was 10.4mg/L. There was no satisfactory explanation for the exceedance and the analysis results for the split sample were not reported.

Action: Analyse samples taken when WW take their samples within 24 hours of being sampled.

Update and re-issue procedures by 23rd March 2016.

The Schedule 1 notification was sent to an obsolete email address, indicating a weakness in the change procedure. This will be audited by NRW before September 2016.

Action: Update change procedures, ensuring that maintenance of correct contact details is included.

Re-issue procedures by 23rd March 2016.

Update procedures for informing NRW of permit breaches, ensuring that all contact details are correct and, if necessary, carry out refresher training.

Action: Update and re-issue procedure by 26th February 2016.
