Forms S1, Emissions to Sewer, R1, Waste Disposal and Recovery, WU1, Water Usage and E1, Energy Usage were received on 27th January 2017.

All the reports are accepted.

Form S1, Emissions to Sewer, 1st July to 31st December 2016

All the parameters were within their respective emission limit values.

Form R1, Waste Disposal and Recovery, 2016

The amount of waste generated increased by 37% per million units of production. This increase is due to more production being processed through the zinc-nickel process.

Form WU1, Water Usage, 2016

Water usage increased slightly in 2016 due to the increase in use of the zinc-nickel process.

Form E1, Energy Usage, 2016

Energy usage and consequent CO₂ released were very similar to those in 2015.

The significant increase in waste generated due to the increased throughput on the zinc-nickel line is a cause for concern. NRW would like TRW to conduct some more detailed investigations to try to identify the reasons and any mitigation measures that could be taken to reduce waste.

EMS Review 2016

The EMS review of progress against targets for 2016 was received on 17th February 2017.

Most of the targets have either been met or investigated and proved not to be feasible at present.

The increase in scrap is a cause for concern and Natural Resources Wales NRW) are pleased that TRW are investigating the reasons. It would be interesting to see the evidence for a reduction in the number of tankers required to remove filtercake due to the fitting of alternative cloths to the filter press.

The training in spillage control seems to have fallen behind schedule, which TRW should try to rectify as soon as possible.

There have been problems in the past with submitting data to NRW on time when the H S & E Manager has been absent. NRW are pleased to note that a suitable deputy has been nominated.
