Improvement Condition 10 in V002 of TRW's EPR Permit stated that emissions to air should be monitored and then, based on these initial results, TRW should propose a monitoring plan for the future. The frequency agreed between TRW and Natural Resources Wales was every three years.

The monitoring report was received on 31st July 2018. The next report will be due in May 2021.

Emissions of hydrogen chloride were measured as 0.04mg/m³ and those of hydrogen fluoride were measured as 0.05mg/m³, both with a 13% uncertainty. These concentrations are considerably lower than the lowest values quoted in the Bref document for the surface treatment of metals.
