The permit variation has been duly made, but the permit has not been issued yet. Emissions from the new plant will be the same as or less than those from the old plant, so the environmental risk in running these trials is minimal.

TRW are therefore authorised to run commissioning trials on this plant until 31st May 2016. This permission will be superseded once the varied permit is issued.
